TUITION FEES 2021/22

You can access information on University fees, bursaries, scholarships and any available help with the cost of fees for your programme (course of study) from the University website. You may be able to take out a loan to cover all or part of your tuition fees.

(On-Campus students referred to in this document means those students who would normally study on-Campus but due to the restrictions imposed in relation to Covid-19 are studying either on-line or through the hybrid model).

For full time programmes of a duration of more than one academic year, the published fee is an annual fee, payable each year, for the duration of the programme. Your annual tuition fees cover your first attempt at all of the modules necessary to complete that academic year which includes a reassessment attempt of any failed components of the module. A re-study of any modules will incur additional charges calculated by the number of credits.

European Union students (not including Ireland) will no longer be able to claim UK Government funding or the lower Home (EU) fee rates for programmes starting from August 2021. European Union students will therefore be required to pay the international fee rate. The UK Government has confirmed that continuing students with an EU fee status who commence prior to 1 August 2021 will continue to pay the Home rate of tuition fees for the duration of their programme.

Exemptions apply to those who have settled or pre-settled status under the EU Settlement Scheme, as well as Irish nationals, who may still be eligible for the UK tuition fee rate and associated financial support. Irish nationals should apply to Student Universal Support Ireland (SUSI).

Home tuition fees may be subject to annual increases but will not increase more than the UK Government's maximum regulated tuition fee limit set for the relevant academic year.

International fees are fixed at the same level as the year of first registration for all years of study on the programme. However, the fee may change if you change your course.

UK Sponsors (e.g. NHS) who sponsor Skilled Worker (previously Tier 2) or Temporary Worker - Government Authorised Exchange (T5) previously (Tier 5) employees on University courses will pay the Home fee for those students.

Any eligible discounts will be applied net of scholarships and bursaries.

Placement year fee waiver:

Students studying an undergraduate course with a placement year and paying Home fees will receive a full fee waiver for their placement year.

Integrated Master's discount:

Students studying a standard tier integrated master's course with a Home fee status, pay a discounted fee of £6,100 in their final year (total price for a standard 4 year

Integrated Masters £33,850). Students studying an enhanced tier integrated master's course with a Home fee status pay a discounted fee of £6,695 in their final year (total price for an enhanced 4 year integrated masters £34,445).

Undergraduate (full-time) scholarships and awards

These offers are for on-campus Home **students** (as defined by UCAS).

1. Teesside University Advance

Teesside University Advance is available to all new entrants enrolling on year 0 or year 1 and direct entrants onto year 2 as a full-time undergraduate degree student for Academic Year 2021/22 on a Teesside University course leading to an award of at least 360 credits delivered on Teesside University's Middlesbrough or Darlington Campus. It excludes direct entrants onto year 3, students repeating year 3 or progressing to year 3 following reduced credit after repeating year 2 study.

As part of the Teesside University Advance scheme the University will offer the following to students:-

- an Apple iPad installed with Office 365 software, the University's student portal, access to email, timetables, virtual learning environment and library resources
- an iPad compatible keyboard
- £100 credit per academic year (up to a maximum of £300) to purchase learning resources from the Online Bookstore. This is subject to eligible students progressing on their course and excludes eligible students that are repeating a year, on a sandwich year or integrated masters final year of study.

Direct entrants on to Year 3 are eligible for £100 credit to purchase learning resources from the Online Bookstore. This excludes year 3 students repeating a year 3 or progressing to year 3 following reduced credit repeat year 2 study.

2. Teesside University International Business School Accommodation award

This award provides £2,000 off first year University accommodation for Teesside University International Business School undergraduate students who live outside of the TS postcode area. 3. Teesside University International Business School Excellence scholarships

4. Marjorie Hearnshaw scholarship

If you have lived in the Tees Valley for over two years, and have applied to study on a full-time engineering programme within the School of Computing, Engineering & Digital Technologies you might be eligible to apply for one of the Dr Ken Home scholarships. You must choose Teesside University as your first accepted choice with UCAS. Eligible students are invited to apply in October 2021. 7. Brittan scholarship

If you apply for a course within our School of Computing, Engineering & Digital Technologies, you could be eligible for a Brittan scholarship. You must also select Teesside University as your firm choice with UCAS. For more information about the Brittan scholarship visit our website.

8. Thirteen Academy scholarship

Thirteen is offering several scholarships to their customers and their families to cover the cost of their Teesside University fees. 9. Teesside Sanctuary award for students seeking asylum

10. Success Photography scholarship

If you are applying to study BA (Hons) Film and Television Production, BA (Hons) Fine Art or BA (Hons) Photography full-time and your household income is below £25,000 you could be eligible for a Success Photography scholarship. 11. Care leaver bursary

Enhanced tier fees:

Enhanced tier fees are charged for some PhD and MPhil programmes in some topics/subject areas in which significantly higher costs are expected to be incurred in supporting the research. These enhanced fees represent a contribution towards these increased costs. Typically programmes charged enhanced tier fees include but are not necessarily limited to research in engineering, bioscience and clinical research requiring use of specialist facilities, high cost consumables and/or software. Where the enhanced tier fee is payable this will be clearly stated in the offer letter.

Writing-up fee (*):

After a period of three years (five years for part-time students), and subject to confirmation from the Postgraduate Research Assessment Board that sufficient progress has been made and that the data gathering and analysis phase of the project has been largely completed, students are entitled to a period of one year (two years for part-time students) at which a reduced writing-up fee is payable. The writing-up fee for 2021/22 is £650 - this flat fee covers the writing-up period. If the work is not submitted for examination within the designated writing-up period, the fee will normally revert to the standard fee for the following year until the date of submission of the thesis. This writing up fee is for students that started their research degree in 2016/7 or later. Students that started prior to this date will be charged the part time fee that was applicable as at their start date.

All Postgraduate Research students who were current between April and June 2020 will be eligible for a 3-month extension to their writing-up period (normally 12 months). This could be further extended by up to an additional 3 months subject to a successful application to the University in respect of their extenuating circumstances.

3. On-Campus Post Graduate taught degree (part-time or full time) - 10% tuition fee discount (Home students only)*

You may be able to benefit from a 10% discount towards a postgraduate taught degree (part-time or full-time) tuition fee if you meet one of the following criteria:

- you are a continuing Teesside University student progressing, with no break in study, from an undergraduate to a postgraduate taught degree course; **or**
- you have completed and graduated from an undergraduate degree course at Teesside University from the academic year 2019/20; **or**
- you have completed and graduated with a first-class honours from an undergraduate degree course at any other university in the last two academic years (2019/20 or 2020/21), supporting evidence is required.

*This offer cannot be used in conjunction with any other fee reduction scheme or discount offer. The University reserves the right to amend the amount of any reduction and/or the qualifying criteria at any time.

This offer applies to students enrolling on a postgraduate course for September 2021 only and the discount will automatically be applied to your fee if you meet the qualifying criteria.

4. On-Campus Postgraduate scholarships and awards (all programmes)

4.1 Dr Keith Skeoch postgraduate scholarship

In 2013, Dr Keith Skeoch generously instituted a new scholarship fund. From this we are offering four £2,500 scholarships to students enrolling on postgraduate programmes at the University's School of Social Sciences, Humanities & Law and Teesside University International Business School. 4.2 Artificial intelligence and data science Office for Students scholarships

You may be eligible for a £10,000 scholarship from the Office for Students if you plan on studying MSc Applied Artificial Intelligence or MSc Applied Data Science. There are 15 scholarships available, each worth £10,000. You must belong to at least one of the following underrepresented groups: female, black, disabled, students from POLAR quintiles 1 and 2, refugees, children from military families, veterans and partners of military personnel. You need a 'conditional' or 'unconditional' offer for one of the courses listed above before you submit your OfS scholarship application. 4.5 Smart card credit

5. Support for On-Campus Postgraduate Research (MPhil and PhD) study

All of the following postgraduate research opportunities are linked to specific research topics and funding routes and are recruited on a competitive basis. A summary of each funded route can be found below. For further details on each of these schemes, their eligibility criteria and how to apply, please see our website (research pages).

5.1 Research Council Doctoral Training Partnership Studentships

The University currently participates in a number of UK Research and Innovation (UKRI) Doctoral Training Partnership programmes. These programmes are open to UK, and international students. UK students who have been ordinarily resident in the UK for at least three can apply for full awards comprising full tuition fees, a stipend to cover living expenses at UKRI rates (£15,609 for 2021/22) and access to the Research Training Support Grant held by the DTP to which students may apply for additional support to cover specific expenses associated with the

programme. International students will become eligible for a certain number of full studentships (30% of the total number of awards available) from 2021.

5.2 University Research Studentships

These are fully funded research opportunities which are offered on a competitive basis, and which cover all fees associated with PhD study, together with a stipend (currently £16,000 per annum tax free, unless stated otherwise) to cover living expenses for four years. Applications are welcome from strong Home and international students. International candidates will be required to obtain the appropriate UK study visa.

5.3 Fees-funded Studentships

These research opportunities are offered on a competitive basis and cover all fees associated with full-time PhD study for up to 4 years. Applications are welcome from strong Home and international students. International candidates will be required to obtain the appropriate UK study visa. As these Studentships do not include a stipend for living expenses, applicants are required to have access to sufficient resources to successfully undertake the PhD on this basis - for example through other funding mechanisms, government sponsorship, self-supporting.

5) Higher Degree Apprenticeships (HDA's) (Standard HDA Fee)

HDA students must be in employment and have a contract signed by the employer before commencing the apprenticeship. A cost of £27,000 for a full degree apprenticeship (£1,350 non-levy paying employer payment of 5% and £25,650 non-levy paying employer government contribution of 95%/100% if levy-paying employer from their Digital Account) equating to £1,500 per 20 credits.

6) Non-standard Short Courses (Module Based) – 60 credits or less (students studying on a short course with a duration of less than one academic year)

- If you withdraw or interrupt within 2 weeks of the course start date you will not be liable to pay any fees.
- If you withdraw or interrupt after 2 weeks from the course start date you will be liable to pay in full for any module started. Any modules not yet started will be removed and credited in full.

7) Non-accredited Employer-led Short Courses (including non-accredited CPD)

If the employer cancels the course not before four weeks of commencement no fees will be due.

Enhanced tier fees:

Enhanced tier fees are charged for some PhD and MPhil programmes in some topics/subject areas in which significantly higher costs are expected to be incurred in supporting the research. These enhanced fees represent a contribution towards these increased costs. Typically programmes charged enhanced tier fees include but are not necessarily limited to research in engineering, bioscience and clinical research requiring use of specialist facilities, high cost consumables and/or software. Where the enhanced tier fee is payable this will be clearly stated in the offer letter.

Writing-up fee:

After a period of three years for full-time (five years for part-time) and subject to confirmation from the Postgraduate Research Assessment Board that sufficient progress has been made and that the data gathering and analysis phase of the project has been largely completed, students are entitled to a period of one year (two years for part-time students) at which a reduced writing-up fee is payable. The 2021/22 writing-up fee is set out above. This is a flat fee which covers the writing-up period. If the work is not submitted for examination within the designated writing-up period, the fee will normally revert to the standard fee for the following year until the date of submission of the thesis. The writing up fee of £650 is applicable to students that started their research degree in 2016/17 or later. Students with a prior start date will be charged the part-time home fee as at their start date in their writing up year.

All Postgraduate Research students who were current between April and June 2020 will be eligible for a 3 month extension to their writing-up period (normally 12 months). This could be further extended by up to an additional 3 months subject to a successful application to the University in respect of their extenuating circumstances.

6. Family Loyalty Discount

The Family Loyalty Discount is for international (non-EU) students studying on campus.

Where a student (the first student) is studying at Teesside University and a second (or further) family member commences study at the University whilst the first student remains enrolled as a student, the second (or further) family member is eligible to apply for a family discount if they apply directly to us and do not use an agent.

The discount applies to eligible family members who are studying for a Teesside University qualification at undergraduate or postgraduate level at the same time as the first family member whereby you have applied directly to us and no agents have been used. The programme of study being followed by all family members claiming the Family Loyalty Discount must be at least 120 credits.

It entitles you to £1,500 fee deduction for the second and any further family members in the first year of study only.

You must be the sibling, spouse, civil partner or child of someone who is currently studying on a full-time course at Teesside University. That relative must also be classified as an international (non-EU) student.

- Siblings: you and your sibling can have one or both parents in common.
- Children/parents: you can be related by blood or by marriage.
- Spouses/Civil Partners: You cannot become eligible for this discount by marrying/entering in to a civil partnership with someone who is currently studying at the University.

It is necessary to apply for the Family Loyalty Discount and we recommend that you apply when registering for your course or soon after. Applications cannot be accepted more than two months after your course start date. Our Admissions team will consider your application and will let you know whether or not it has been approved.

Where the University is required to pay Agent's commission in respect of a student enrolment any Family Loyalty Discount awarded in error will be cancelled and the student will become liable for the increase in fees due.

Support for On-Campus Postgraduate Research (MPhil and PhD) study

All of the following postgraduate research opportunities are linked to specific research topics and funding routes and are recruited on a competitive basis. A summary of each funded route can be found below. For further details on each of these schemes, their eligibility criteria and how to apply, please see our website (research pages)

1. University Research Studentships

These are fully funded research opportunities which are offered on a competitive basis, and which cover all fees associated with PhD study, together with a stipend (currently £15,000 per annum tax free, unless stated otherwise) to cover living expenses for three years. Applications are welcome from strong UK and international students. International candidates will be required to obtain the appropriate UK study visa unless they are eligible Home candidates.

This is providing you apply directly to us and do not use an agent. The £1,000 is awarded as a discount on your first-year fees for the next programme.

Early payment discount:

HNC/HND**Course costs:**

For a Higher National Certificate (HNC) you study eight modules at £495 for each module. For the Higher National Diploma (HND) you study a maximum of 16 modules, again at £495 each. You usually pay for one module at a time. Some modules are subject to availability.

If you join the course having completed no appropriate HNC modules previously, the total cost of an HNC is currently £3,960 for the 8 modules required and an HND is another £3,960 on top of this for the additional 8 modules you will need to study

All payments for modules must be made through the Online Shop, unless alternative arrangements have been specifically agreed.

Paying Tuition Fees:

The options for paying tuition fees are detailed in the University's Fees and Charges Regulations 2021/22.

The preferred method of payment is via the University's online payment site at www.tees.ac.uk/payonline and selecting "*pay a student invoice.*" Student ID number and date of birth are required to validate the account.
